### **PJSC Cherkizovo Group pays dividend for 2015**

**Moscow, Russia - 9 June 2016 - PJSC Cherkizovo Group (LSE: CHE; MOEX: GCHE), the largest vertically integrated meat and feed producer in Russia, announces that it has paid a total dividend of RUB 2,000,351,671.50 to its shareholders for 2015. The final dividend payments were made on 8 June, 2016.**

The dividend for the full year includes the RUB 1,000,175,835.75 the Company already paid in interim dividends for the first half of 2015. For the full year, a dividend of RUB 45.50 per ordinary share has been paid to shareholders, which includes the RUB 22.75 per ordinary share that was paid for the first half of the year. Three Cherkizovo Group GDRs correspond to two ordinary shares.
